



## STATUS CODES

- Manual Declarations ..... *not applicable*  
 CES Modules which uses this data ..... **IMPORT SYSTEM**
- Tab 7 - System Document Body

**Reference Data:** ..... These are internal system codes which are not inputted by the user but are generated as an indication on the current status of an inputted declaration.

**The status code of a given declaration can be seen in "Tab 7 - System Document Body" in the field "Status Code".**

Status Code	Description
0	Create declaration.
1	Current notice. Create draft declaration.
2	Creation completed.
3	Correction of declaration.
4	Creation of estimated assessment.
5	Correction of declaration.
6	Regulation of declaration (Correction).
7	Regulation of declaration/item (Delete).
8	Postpone correction respite.
9	Error in declaration.
10	Approve by the system (with expected arrival).
11	Approve with expected arrival.
12	Approve with actual arrival.
13	Approve missing function separation.
14	Approve compare the function separation.
15	Maintain DS probability check.
16	Manual acceptance for more conditions (status code 17, 18 and 19).
17	Manual acceptance (guarantee for temporary antidumping).

<b>28</b>	<b>Waiting for other manual release than Goods regulations e.g. check of payment.</b>

31	Released (automatic after control). *
32	Released (automatic after evaluation). *
<b>40</b>	<b>Accepted and Released.</b>
51	Automatically change of declaration type

Status Code	Description
98	Deactivated
99	Deactivated ? moved to archive on other media.

**Comments:...** Of particular importance are the following three status codes;

- 1. Status Code 22. Automatically taken out to control (red).**  
Following Risk Analysis, the declaration has been flagged as high risk. This means that the declaration is selected for control.
- 2. Status Code 28: Waiting for other manual release than Goods regulations e.g. check of payment.**  
For the status code to change, the declarant must first pay the taxes due to Customs.
- 3. Status Code 40: Accepted and Released.**  
All payments and/or controls have been effected. The goods can now be released.

**It is important to remember that goods can  
only be released after declaration reaches  
Status 40.**
